Kevin Standbridge provided an update on the Open Space and Trails Committee (OSTAC) discussion of the public art proposal. OSTAC is struggling with the suggested location and how public art interacts with open space. OSTAC members are as passionate about open space as Public Art committee members are passionate about public art. They see the beauty in the open space. Broomfield Master Plan and City Council concur that public art is feasible in open space. In order to move forward, Kevin suggests PAC and OSTAC sit down together to share their mission and objectives and to find areas of intersection and common interest. Then the group can create criteria for moving forward with specific projects.

Public Art committee members are open to meeting with OSTAC. A concern is the need to create a timeline for decisions. PAC agreed to have Kevin facilitate the discussion with OSTAC. Karen Gerrity and Kristan Pritz will coordinate planning of the meeting in the first half of March.
