**General Construction, Mechanical, Plumbing, Electrical
Permit Fee Schedule**

Permit fees for each trade (general, electrical, mechanical, plumbing) are calculated separately based upon the value of the work performed. For values of \$1.00 to \$2,000.00 the following fee schedule is used. \$23.50 for the first \$500.00, plus \$3.05 for each additional \$100.00 or fraction thereof, to and including \$2,000.00.

For values greater than \$25,000, fees shall be assessed in accordance with IBC Table 1-A as amended.

Use Tax:

The City and County of Broomfield collects use tax on building materials at the time of building permit issuance. For use tax purposes, 50% of total project valuation is assumed to be materials with the balance being labor. When purchasing materials for the project, show the building permit payment receipt to the supplier. The supplier should not charge any city sales tax since the Broomfield use tax has been paid. Questions regarding use tax audits can be answered by Roxy Huber in the Broomfield Finance Department at 303-438-6287.

Use Tax = Total valuation x 50% (materials) x assessed rate: 4.15% City and County of Broomfield Tax

Inspections:

Please call 303-438-6376 to schedule inspections. Inspection requests must be called in by 4:00 p.m. on the business day prior to the day of the inspection. Monday inspections must be called in by 4:00 p.m. Friday.

Mobile Home Park Set-up Fees:

Permit Fees for Mobile Home Park Set-Up = \$ 50.00 (use tax is not charged).

Permit Fees for Mobile Home Park Electrical Hook-Up = \$ 50.00 (use tax is not charged).

All construction and/or sales trailers are charged \$ 100.00 for each application submitted and each time they are moved (\$50.00 set up, \$50.00 electrical).
