

EMPLOYEES' REVIEW COMMITTEE

In order that the opinions and viewpoints of employees may be fully considered when management develops personnel policies, full-time and part-time City and County employees select fellow employees as representatives to the Employees' Review Committee. In addition to assisting the Manager of the City and County of Broomfield and the Human Resources Department in reviewing personnel policies, the Committee provides valuable assistance in developing and maintaining the City and County's fringe benefit package. Representatives to the Committee serve a two-year term with one-half of the Committee membership being elected in January of each year. Representatives express their constituents' views at periodic meetings and report back on subjects discussed.
